2019 was the final year of the Eurasian Harm Reduction Association (hereinafter EHRA) <u>Strategic Framework 2018-2019</u>. We have successfully implemented the Strategic Framework and achieved tangible results to serve basis for further advocacy.

We have strengthened

- ✓ democracy and transparency in governance;
- ✓ organizational and <u>programmatic</u> capacity;
- ✓ financial sustainability.

287 <u>members of EHRA</u> are actively involved in organizational decision making and governance due to the EHRA credibility as demonstrated through transparent management and proven results. In 2019 the new EHRA strategy for 2020-2024 has been



developed by the <u>EHRA Steering Committee</u> with involvement of EHRA members and partners.

> We have gathered credible evidence for strong national advocacy on:


- ✓ sustainability of opioid agonist therapy in the context of donor transition;
- ✓ client satisfaction with opioid agonist therapy services;
- ✓ new psychoactive substances use in <u>Belarus</u> and <u>Moldova</u>;
- ✓ <u>sustainability Bridge Funding: Case Study from Bosnia and Herzegovina, Montenegro and Serbia;</u>
- ✓ human rights violations against people who use drugs documented by EHRA in Estonia, Kazakhstan, Kyrgyzstan, Moldova and Russia;
- ✓ <u>criminalization of drug use</u> and possession costs for society;
- ✓ innovations such as <u>drug checking</u>, <u>drug consumption rooms</u>, harm reduction at music festivals, involvement of peer consultants.

We have developed tools and guidelines to support leadership and expertise of civil society in:

- ✓ budget advocacy;
- ✓ community-led monitoring / assessment;
- ✓ <u>alternative financing and models of sustainable development</u> for non-profit organisations;
- ✓ <u>transition from the Global Fund support to national funding</u> of HIV and TB programs: role, opportunities and priorities for the civil society;
- ✓ effective work of civil society constituency in CCM;
- ✓ the Civil Society and Eastern Europe and Central Asia Delegations to the Board of the Global Fund to Fight AIDS, Tuberculosis and Malaria;
- ✓ HIV and TB related technical support in EECA region 2019.
- We have contributed to capacity development of national and local community of people who use drugs and civil society leaders including EHRA members. Since 2017 we've continuously supported organizations and community-led initiative groups through a unique system of <u>small grants</u>, accompanied by daily mentoring, mutual training and

best practices exchange, advocacy support from the regional level, establishing working relationships with international partners and decision-makers in CEECA countries. Only in 2019, 25 community-led and civil society organizations from 16 countries of CEECA have received such support.

- We have strengthened the strategic partnerships with broader civil society movements in CEECA. EHRA has established strong cooperation with IDPC, HRI within the International Harm Reduction Consortium. EHRA is leading the Eurasian Regional Consortium, cooperating with EWNA and ECOM. In 2019, we began to build new partnerships and look for new advocacy allies. Our participation in the 13th annual conference of the International Society for Research in Drug Policy and the Lisbon Addiction Conference gave us the opportunity to build cooperation with researchers. Cooperation with broader human rights movement in the region has started in the area of protection rights and freedoms of people who use drugs, specifically in issues of personal safety of activists and protecting right to health and right to information. Feminist movements have become our new allies in the fight for a humane drug policy.
- We have continued support to regional campaigns and government advocacy in 2019 to ensure human rights protection and sustainability of harm reduction services:
 - √ harm reduction programs without decrease of national funding in Czech Republic were supported by more than 100 organizations of the region;
 - ✓ harm reduction programs started to be funded from national resources in Bulgaria, Kyrgyzstan, Moldova and Ukraine;
 - ✓ <u>advocacy actions</u> to sustain harm reduction services in the South East European countries of Albania, Bosnia and Herzegovina, Bulgaria and Romania;
 - ✓ shadow reports to the 65th session of CESCR on the violation of the rights of women who use drugs in Estonia, and on access to OST for people who use drugs in Kazakhstan; report to the 74th session of CEDAW on discrimination and violence among women who use drugs, women living with HIV, sex workers and women in prison in Kazakhstan described human rights violations cases, discriminating barriers and requested the information



- on state measures to protect people who use drugs from discrimination and illtreatment, as well as on access to life-saving medicines and services.
- ✓ EHRA's continued coordination of #ChaseTheVirusNotPeople EECA community campaign to reduce stigma and discrimination in cooperation with 7 other regional community networks and numerous national NGOs and activists. Zero Discrimination Day initiative, national campaigns in Armenia, Azerbaijan, Kazakhstan and Russia, other regional networks' initiatives within the campaign have forced national stakeholders and UN agencies to prioritize the elimination of stigma, discrimination and criminalization of key affected populations as key barriers to effective HIV response in the region.

- ✓ The project aims to support management of the campaign to ensure the engagement of all regional networks – organisers of the campaign – into the decision making on strategic planning of the campaign and further development;
- ✓ Support to the campaign website and campaign pages on social media;
- Mentorship of national teams developing campaigns at country level, and regional community teams developing specific community campaigns at the EECA level.

- the project supported the campaign <u>website</u> with 1,711 visitors;
- number of campaign supporters grew to 102 organisations from across the EECA;
- campaign conducted online and offline through mobilisation action on "Zero Discrimination Day" with 3,309 contacts and 47 posts on social media. Within the Zero Discrimination Day action, the contest on best video and photo of activists and community representatives from across EECA conducted with 5 winners identified and awarded with campaign promotional materials:
- the campaign has around 1,000 followers on its pages on social networks: <u>Facebook</u>, <u>Twitter</u>, and <u>Instagram</u>;
- The EHRA campaign coordinator participated as a trainer in the training for MSM and trans* people from Armenia, Belarus, Georgia, Kyrgyzstan and North Macedonia, organised by ECOM, on the adaptation of the campaign to the community needs of MSM and trans* people and to the national context of each country.

6. Women Using Drugs in the EECA Region (AWID 2018)

Target Countries and territories: Estonia, Kazakhstan, Kyrgyzstan, Lithuania, Russia, Ukraine



Aim / Objectives:

- ✓ Coordination with project participants of a research project on the impact of the criminalisation of drugs on women using drugs in the EECA.
- ✓ Support for a webinar on feminism for women working on drug policy in the EECA.
- ✓ Coordination of project communications and general administrative support.

- Together with 40 women from the Eurasian region, discussed drug policy, intersectional feminism, harm reduction and human rights;

7. Support to the Legal Environment Assessment in Armenia on HIV and TB in 2019

Aim / Objectives:

The Armenia Legal Environment Assessment (LEA) on HIV and Tuberculosis has to review laws, regulations and policies, law enforcement, legal empowerment and access to justice in the context of health, to identify the nature and extent of stigma, discrimination, gender inequality, gender – based violence and other human rights – related barriers to services experienced by people living with HIV and\or affected with TB.

The findings and recommendations from the LEA will serve as the basis for the formulation and advancement of key policy changes to affect and accelerate access to health services at a crucial time as the country is preparing to take over the response to these epidemics with decreasing donor funding.

Target Countries and territories: Armenia



- LEA consultants developed the inception report that was translated into English;
- Communications were conducted to discuss the inception report with a UNDP international consultant, LEA Team and the Global Fund;
- The LEA Team conducted a meeting with the CRG Working Group under the CCM to agree on additional chapters on tuberculosis to be added to the inception report;
- The LEA Team has started to make adjustments to the inception report and in enlarging the TB section.

8. Peer2Peer: Reinforcing Peer Involvement in Outreach Work

Donor: European Commission



Duration: Mar. 2019 – Oct. 2020

Budget: EUR43,378

Project Status: In progress

Target Countries and territories: Portugal, Greece, Poland, Lithuania, Belgium, France, the Netherlands, Hungary



Aim / Objectives:

- ✓ To mitigate gaps in scientific literature regarding formal and informal cooperation between key actors in outreach interventions addressing people who use psychoactive substances;
- ✓ To validate the effectiveness of cooperative practices in outreach work through case studies at a local level;
- ✓ To advocate for the upscaling of evidence-based cooperative practices in outreach interventions, especially the integration of peer educators (PE). The active participation of different key actors will promote the upscaling of European heritage and the advocacy function of CSOs;
- ✓ To develop dissemination strategies targeting a large audience, maximising the project impact by raising the general public's awareness of the need to develop more effective approaches to support people who use psychoactive substances.

- Partners <u>kick-off meeting in Porto</u> to discuss overall project activities and the research component of the project;
- Needs assessment focus group was conducted in Lithuania (8 participants) with the main stakeholders;
- Prepared content analysis based on the needs assessment focus group;
- Lithuania National Report was prepared based on analysis of national legal acts;
- Mid-term partners meeting was held in <u>Amsterdam</u> to discuss results of the research and continuation of the project;
- Study visit to <u>Antwerp</u> (Belgium) was organised to learn from partner best practices (C-buddy project, night-shelters, housing projects);
- Developed National Advocacy Strategy for Lithuania as the basis for the pilot intervention.

- ✓ Development of an online methodology for monitoring and analysis of the implementation of transition conducting plans, regular monitoring and analysis implementation of the transition plans in those project countries where transition plans are being developed.
- ✓ Collection and analysis of data on human rights violations and the quality of services for drug users, the development of a system of follow-up reaction, including the submission of cases to international human rights instruments.
- ✓ Conduct a seminar for activists and professionals from Bosnia and Herzegovina, North Macedonia, Montenegro, Romania and Serbia to collect data on human rights violations and reaction mechanisms.

- In September 2019, EHRA submitted the Complaint to the Office of Inspector General of the Global Fund in accordance with the Global Fund Human Rights Complaints Procedure in a response to the inadequate, threatening and discriminatory actions of the Republican Scientific and Practical Center of Medical Technologies, Informatization, Management and Economics of Public Health (Belarus) towards Ms. Parfenyuk.
- Russia: legal analysis of 27 interviews reflecting cases on human rights violations among women who use drugs in Saint Petersburg.
- Moldova: collected data on human rights violations among people who use drugs and developed an analysis to support advocacy for development and coming into power of law amendments decriminalising possession of drugs for personal use and changing of dosage and introduction of alternatives to coercive sanctions.
- Kyrgyzstan, Ukraine, Belarus: conducted interviews on human rights violations and access and quality of OST services; collected official statistics and information related to fines for possession of drugs.
- Representing reports with community leaders in CEDAW and the UN Committee on Civil and Political Rights.

Aim / Objectives:

- ✓ Provide TA to CSOs and CBOs in transitioning countries to assess the impact of the GF transition-related processes taking place in countries on the quality and other aspects of sustainability of OST services which intend to conduct monitoring of implementation of transition plans;
- ✓ Collect cases of human rights violations in selected EECA countries, submit reports to the UN treaty bodies, and conduct activities aimed at raising the capacity building of communities, NGOs and human rights activists in addressing human rights violations in EECA countries.

- In 2019, EHRA received technical support to activities complimentary to the EECA multi-country project, "Sustainability of services for key populations in Eastern Europe and Central Asia", implemented by the Alliance for Public Health and financed by the Global Fund, where EHRA is contracted as a sub-sub recipient by the sub-recipient All-Ukrainian network of people living with HIV/AIDS ('100% Life').
- Within the UNAIDS Technical Support Mechanism (TSM) grant in 2019, EHRA hired an international human rights expert to assist EHRA with submissions to UN treaty bodies and to prepare and conduct regional training on documenting human rights violations for South East European countries in early 2020.

11. New Psychoactive Substance Use in Moldova and Belarus

Aim / Objectives:

To generate a more accurate picture of the use of new psychoactive substances (NPS) in Belarus and Moldova which will then be used to inform both policy advocacy by domestic civil society organisations as well as to contribute to the international peer reviewed literature on NPS use.

- 2 national reports on the use of NPS in Belarus and Moldova were prepared and published.
- A <u>seminar</u> was held at Swansea University, Wales, under the auspices of the Centre on Criminal Justice and Criminology on the project and its findings.
- Results of the research were presented in the <u>Lisbon Addictions 2019 conference</u>.
- Based on the results and methodology of the project, an application was prepared on NPS use in Kazakhstan, Kyrgyzstan, Serbia and Georgia and funding was secured.

Aim / Objectives:

- ✓ Assessment of models and approaches used in OST in the process of its transitioning to domestic funding by (1) developing and promoting an OST-specific version of the Transition Readiness Assessment Tool; and, (2) developing tools to conduct regular monitoring of access and quality of HIV services.
- ✓ Capacity building of EHRA to better advocate for human rights violations among women using drugs and OST programmes in the EECA.
- ✓ Support of EHRA governance and sustainability systems through working meetings to finalise current fundraising approaches and to prepare for the organisational strategic planning process for 2019.

- A draft guide was developed for assessing the sustainability of Opioid Agonist Therapy (OAT) in the context of donor transition and approach and the sustainability of the programmatic aspects of OST services in EECA countries transitioning from Global Fund support to national funding.
- A team of sociologists, in close collaboration with EHRA staff, developed the protocol and informed consent forms and conducted 9 semi-structured interviews with OST clients and 1 with a service provider; they prepared a data collection tool in consultation with community and harm reduction experts and received IRB approval in Ukraine.
- In February 2019, during the 65th session of the Committee on Economic, Social and Cultural Rights (CESCR) in Geneva, Switzerland, EHRA, in partnership with the Canadian HIV/AIDS Legal Network (CALN), joined by community representatives from Estonia presented the statements on the enjoyment of rights among women who use drugs in Estonia and addressed the questions of the Committee.
- A set of documents have been developed, including an EHRA fundraising plan for 2019-2020 and tools for the EHRA Strategic Framework evaluation and plan as part of the EHRA strategic planning process in 2019.

EHRA as a Fiscal Agent for regional community-led networks

EHRA acknowledges the principle of greater involvement of key communities, including people who use drugs, in policy and advocacy work as well as in programmes and services that affect their lives at all levels. EHRA encourages the development of emerging regional community-led networks as they play a crucial role in advocacy for better policies and practices in healthcare and in protecting the human rights of key communities. Among other

types of support, EHRA acts as a Fiscal Agent for regional community-led networks, thereby backing up their financial and

administrative management.

In 2019, EHRA was a Fiscal Agent of the Eurasian Network of People Who Use Drugs (ENPUD). The main principles and aims of the mutual work are defined in a Memorandum of Cooperation signed between EHRA and ENPUD. 

EHRA's Programmatic Plans 2020

2020 will be the first year for the implementation of the recently developed organisational Strategy, 2020-2024, with an upgraded and ambitious mission and reshaped goals and objectives.



EHRA's MISSION: to actively unite and support communities and civil society to ensure the rights and freedoms, health and well-being of people who use psychoactive substances in the CEECA region.

Strategic Goal 1. Develop and support national movements of allies advocating for **legal** regulations aiming at decriminalisation, dependisation and the protection of the rights of people who use psychoactive substances.

Planned activities for 2020:

- ✓ Regional workshop for 25 community activists and experts from South-Eastern Europe (Bosnia and Herzegovina, North Macedonia, Romania, Serbia and Montenegro) on collecting data on human rights violations and implementation of response mechanisms.
- ✓ Implementation of the Learning Cycle on State budget monitoring and accountability. The Cycle includes a regional expert meeting; a regional workshop for 15 civil society and community representatives; awarding of 6 small grants, followed by the provision of expert technical assistance and mentorship.
- ✓ Delivery of the advocacy campaign, "Chase the virus, not people", at national level by providing 4 small grants to CSOs and CBOs in EECA countries.
- ✓ To develop and promote innovative approaches and methods on drug education among youth workers, peer educators, outreach workers and harm reduction specialists who directly work with youth who are potentially, or who are already, using drugs.

Strategic Goal 2. Strengthen advocacy for access to high-quality, evidence-based, gender-transformative, non-discriminatory harm reduction services in free and closed settings that have proved to be effective and based on people's needs and human rights.

Planned activities for 2020:

- Submission of 2 cases to international human rights treaty bodies of human rights violations faced by people who use drugs in Ukraine and Belarus.
- Active participation in the development of European and national advocacy strategies to strengthen outreach work in harm reduction.
- Proven research methodology will be used to generate a more accurate picture of the use of new psychoactive substances (NPS), harm reduction and law enforcement responses to the emerging NPS in Kazakhstan, Kyrgyzstan, Georgia and Serbia.
- Data collection and analysis of human rights violations and quality of services for drug users in EECA countries; development of a follow-up system, including submission of cases to international human rights protection mechanisms.

Strategic Goal 3. Ensure **sustainability of harm reduction services** as part of the transition from donor support to national funding.

Planned activities for 2020:

- ✓ Provision of technical assistance to civil society and community organisations in monitoring of implementation of transition plans to assess the impact of transition on national funding and the quality of Opioid Agonist Treatment in EECA countries.
- ✓ Development of methodology for online monitoring and analysing of transition plan implementation; conduct regular monitoring and analysis of implementation of transition plans in countries where transition plans are being developed.
- ✓ Continuation of hosting of the Regional Civil Society and Community Support, Communication and Coordination Platform in Eastern Europe and Central Asia.

Strategic Goal 4. Ensure efficiency and sustainability of EHRA.

- Regular Steering Committee (SC) meetings and annual General Assembly (GA).
- Active fundraising to ensure financial and programmatic sustainability.
- Regional workshop on CSO and CBO organisational sustainability and practice of alternative funding with a focus on EHRA members.
- Maintain strong alliances with regional key community networks, human rights and feminist associations.
- Increase expert capacity of EHRA staff and members by providing educational events and sharing information via EHRA communication channels.


Organisational risks and their management

In the process of developing the new strategy, 2020-2024, EHRA identified risks that may potentially occur in the implementation of the Strategy. EHRA considers risk management comprehensively, covering all aspects that may affect achievement of EHRA's strategic objectives. These aspects include potential risks in governance/decision making; finances/resources; operational planning and programme implementation; the environmental and political situation in countries of the CEECA; and risks related to EHRA members and beneficiaries. EHRA manages risks by anticipating them, preventing them from happening and minimasing their effect, if they occur. Risks only with high likelihood or impact are included in the table below. All identified potential risks and their management are being recorded in a risk register and are being regularly revised.
